- The Institute Strategy document has a plan for five years, action items and key indicators i. e. (2019-20, 2020-21, 2021-22, 2022-23, 2023-24)
- The Strategy document process has created a participatory process for involving stakeholders in the visioning and planning process of the Institute.
- Strategic goals were finalized keeping in view vision and mission of statements, quality policy, core values, SWOC (Strengths, Weaknesses, Opportunities and Challenges) analysis, current environmental, social, technological and competition factors.

- Industry-Institute Interaction Programs were conducted
- Weaker students are identified subject wise and wherever it is necessary separate sections are created.

- To improve communication skill, subjects like communication skill I and II are introduced at first year level. Further 120 hours of soft skills trainings are provided for personality development.
- Modern equipment, instrumentation, software's etc. are procured and being under use.
- Total number of research papers published by faculty in SCI rated journals in last 3 years are 10
- 14 International Conferences were attended and papers werepresented by the faculty abroad.
- National Conferences/Seminars/symposium/workshops were attended and presented 24 papers by various faculty members
- 16 training programs were attended by the faculty members
- 2 Papers were published by students in Indian Journals co-authored with faculty
- 3 faculty members have completed MOOC courses successfully with merit.
- Students published 1 Paper in International conference in India
- A well-defined decentralized governance system is in place
- There is a grievance redressal mechanism for students, faculty and staff in place
